Both speakers gave a little information about their background, Stuart being the manager at the Talyllyn Railways and Russell the new owner of Cadfan News. Both have been involved in PR projects and Russell has direct involvement with a Town Centre Partnership which included major high street retail outlets.

The Mission Statement of the group was delivered as:-

'To ensure our town is safe, clean, attractive and vibrant. To encourage all businesses and organisations to work together for the benefit of the town, it's residents and its visitors. To help each other in an open and positive way to ensure Tywyn continues to develop and thrive.'

The speakers gave an overview of the situation in retail at present and highlighted the issues facing town centres in the current climate of austerity. This demonstrated a timely need for co-operation between community groups and the Council.

The Regeneration Group went on to detail its future plans potential steps forward. It plans to hold a public meeting and wants opinions on 3 projects that have been its focus. These are picnic benches for the promenade, palm trees for the sea front and banners on the lampposts in the town.

The group hopes to raise about £10k to achieve these goals and already has pledges of around £5k. The Council will be approached in the future for funding.

- Public and private sector leaders came together to discuss a 'Growth Deal' for the region at a summit, the aim was to discuss ways to increase the value of the North Wales economy.
- Charges to the Telecare service are to be increased in early 2019 from £3.30 to £4.50 per week.
- Paper recycling bins in the Leisure Centre car park to be removed.
- 'Job and Knock' style of shift work to be stopped in Gwynedd Council
