The presenters introduced themselves, Billy Simkiss as the Chair of the club and Robert Davies as the club ambassador who has returned to Tywyn in recent times having been a professional footballer for West Bromwich and being capped for Wales.

They went onto explain that due to unmodernised facilities, talented youth from Dysynni are forced to train outside the area. The facilities at the Leisure Centre and at the Cae Chwarae in Bryncrug are not able to support the Club's ambitions.

The club is looking for the support of the Town Council in its bid to develop Cae Rhianfa, the school's playing field, into a suitable facility which will then be an attraction to the town. They hope that the town will be able to host a state of the art 3G pitch with seating and a clubhouse allowing them to achieve their goal of becoming a Football Association Wales, Platinum accredited Club.
