Cl. 048 PRESENTATION: STARDISC, REBEKAH PUGHE AND DEBORAH JARVIS

14.07.21 Presentation by Deborah Jarvis and Rebekah Pughe about the Stardisc Project created by artist Aiden Shingler. The presenters detailed a project in Wirksworth, Derbyshire which consisted of a 40ft granite art installation that depicted the Northern hemisphere and acted as a base for various community events and a learning platform.

The artist is keen to get more of these installations across the UK and to ultimately link these up creating a nationwide trail.

If one of these installations were to go ahead at Ynysymaengwyn it would be the first in Wales.

The disk is made from black granite imported from China and questions were asked regarding the possibility of it being made from local stone.

The price was quoted as being in the region of £125k + VAT + Installation. It was stated that the artist's team and Rebekah Pughe would be very pro-active in applying for funding and had a proven successful track-record and evidential data from the first installation as to the community benefits.
