Question on the loss of the Dentist in Tywyn in March 2022.

Councillors Stevens and Lloyd-Jones to discuss with Betsi Cadwallader at their next meeting.

Question for the Environment Committee. Noted with thanks the work undertaken by the Committee with Llechi improving signage at the front. Suggested a Dysenni Walks Trail in the future. Concerns re safety, security, accessibility, dogs on leads etc.

This is a public footpath under Gwynedd Council jurisdiction. There is tourism potential.

River Walk – there is danger of erosion. Committee will look at the problem in the future.

Noted that progress has started with a nature trail. Survey carried out at Ynysymaengwyn. Lot of work done already on signage and directions. Part of the path comes under the National Park.

Question on Ynysymaengwyn. Concern that the public has lost the right of way to land. Very high fence and stile installed is very high, stile is discreminatory by being inaccessible to some. Has there been an AGM? Letter and e-mail sent with concerns. received no response. Council asked for letter and e-mail to be re-sent to the Town Clerk. Concern expressed that no minutes have been made available from the Trustees.

10.11.21 Councillor Evans advised of concerns raised by a resident of the dangers to riders with ponies crossing the road at Pall Mall Farm to get to the field and having to deal with the speed of traffic.

Resolved that a request be made with Highways Department at Gwynedd Council for appropriate signage to warn motorists.

Cl. 126 TO DISCUSS THE RENEWAL OF THE ANNUAL MEMBERSHIP OF ONE VOICE WALES.

One Voice Wales had contacted the Clerk to advise that the renewal premium of £672 for the Membership of the organisation had not been paid for the year 2021/2022.

Concerns were expressed that the organisation will only deal with the Chairperson or the Clerk and would ask that any advice sought from One Voice Wales should be given in writing.

Proposed by Councillor McCoo, seconded by Councillor Pughe and **resolved** that the Membership of One Voice Wales is renewed for the year 2021/2022 at the premium of £672.

Cl. 128 OPPORTUNITY FOR TYWYN TOWN COUNCILLORS TO ASK QUESTIONS AND REQUEST

10.11.21 <u>ASSISTANCE FROM GWYNEDD COUNCILLORS REGARDING MATTERS WITHIN THE REMIT</u> OF GWYNEDD COUNCIL.

Councillor Evans asked about monitoring of the amount of traffic and its speed on Happy Valley Road

Councillor Lloyd-Jones advised that she would make enquiries about whether it has been carried out.

Councillor McCoo asked about paper recycling at the Leisure Centre following on from the presentation given by Councillor Stevens sometime ago.

Councillor Stevens advised that he will chase it up and would also enquire about a full recycling site in Tywyn. Gwynedd Council has identified a possible site and is investigating the costings.

Councillor Alun Wyn Evans enquired about the Wynnstay Farmers who are planning to move their site to the High Street. A planning application has been submitted but has been returned to Wynnstay advising that the site is on a flood plain. Councillor Evans asked if it was possible to look at the Planning.

Councillor Lloyd Jones advised that notificiation of planning applications has not been coming to the Town Council.

The Clerk to chase up the Planning Department to advise that notification of planning applications is currently not being received by the Clerk.

Concerns expressed at how much of Tywyn is being identified as flood plain areas by Natural Resources Wales.

Councillor O'Hara raised concerns about the positioning of a bench opposite Sandilands Field. Councillor Stevens agreed to look at the bench.

Cl. 129 TO RECEIVE AN UPDATE ON THE ARRANGEMENTS FOR REMEMBRANCE SUNDAY,

10.11.21 **14th NOVEMBER 2021**.

Marching from Bryn y Paderau to the Church. Requested high viz vests from the Office for the front and back of the Parade and asked for councillors to act as volunteers to assist with the Parade.

Confirmed that Members should meet at Bryn y Paderau at 10.45 for the Service to begin at 10.50 with the 2 minute silence at 11 o'clock.

It was noted that the Royal British Legion is active in Tywyn and they would normally arrange the Remembrance Service. Councillor O'Hara apologised for the incorrect information.

There would be no refreshments provided by the Royal British Legion this year.

Neuadd Pendre would be open on the day.

Cl. 130 TO RECEIVE THE CLERK'S REPORT.

10.11.21 **Website** – The Clerk gave apologies for the website not being updated. For some reason the Council had been frozen out of it and despite a request made some time ago for access and a promise made that it would be given, it was not receive it so it has been chased that up. A request was received from a resident for the minutes to be put on the website so an email had been sent to the gentleman with the Minutes attached and an apology and explanation.

Recruitment of New Town Clerk – An update on a start date was requested and Chris had suggested Monday 29th November 2021 so a Contract to be drawn up for Council approval. In view of this, Council will need to decide how long the Locum should stay as the SLCC requires four weeks notice of the end of an assignment.

Tenancy of the Station Building – the tenancy was signed by Councillor Eileen Jones last week and the exchange of documents took place last Friday and the keys were handed over on Monday 8th November. This was all done with the very efficient assistance of Morris and Bates, Solicitors in Aberystwyth.

Unity Bank – Clerk was frozen out of Unity Bank at the beginning of October so that meant that payments could not be made for three weeks but those have now been made.

Code of Conduct – The Clerk reminded everyone that any items discussed under Part 2 of the agenda are confidential and as such should not be discussed with anyone outside of the Town Council. To do so is a breach of the Code of Conduct and knowledge of such a breach should be reported to the Public Services Ombudsman for Wales.

E-mails etc – It has been a very busy month with many e-mails received and sent but the Clerk advised that she had just about managed to keep up with them and responded on a daily basis. At this point, the Clerk gratefully acknowledged the help that she had received from the Councillors which had been outstanding and had made life much easier. The Clerk also thanked all for their kindness and support during a difficult and busy personal time. She had been really moved by the kind e-mails that she had received and thanked the Members very much.

Proposed by Councillor Lloyd-Jones, seconded by Councillor Stevens and **resolved** that the Clerk's Report be accepted and it was agreed that the Locum Clerk should remain with the Town Council until 31st December 2021 following which she had agreed to help the Clerk if required.

(i) E-mail sent on behalf of Trywydd Iach – Outdoor Health Project regarding 'contained fires' at Ynysymaengwyn Trust.

Request by Wellbeing Group for an open fire. Whilst being sympathetic with their holistic approach to mental health it has been pointed out to the group that open fires are not allowed due to the obvious risk by fire to the flora and fauna and adjoining properties. Signage to this effect has been in place for over thirty years and enforced by Ynysymaengwyn staff over these years and not something recently adopted.

It can now be officially confirmed that we have again been successful in gaining the Green Flag Award and I'm sure that the Council would agree that Mark, Rita and staff should be commended on their continued hard work to preserve and improve the standard of woodland and garden areas.
