Cllr. John Pughe reported on progress that Gwynedd Council are making at the Corbett Arms Hotel with money being made available to secure and make safe the building. It is expected that further court cases will be required ahead of a forced sale.

Cllr. Aled Lewis asked if there was any news on posiible budget cuts by Gwynedd Council. Cllr. Anne Lloyd-Jones responded that discussions have been held but more meetings are needed before the budget can be set.

Cllr. Cathy Evans asked about the opening times for the Minor Injuries Unit at Tywyn Hospital. The Clerk responded that the Unit was able to open 5 days a week Monday to Friday from September 25th.

Cllr. Marisa O'Hara asked if there was an update on the parking issues along Idris Villas. Cllr. John Pughe responded that the planned improvements have not yet been implemented but will involve extending the length of the double yellow lines.
